1. FOREWORD

Under the accession negotiations of the Republic of Croatia to the European Union, the Intellectual Property Law has been singled out under separate Chapter 7. In addition to the harmonization of legislation, a special attention in this Chapter has been paid to the provision of effective enforcement of intellectual property rights. The negotiations for the opening of the Chapter 7 were conducted on 29 March 2007, and the preliminary closure of the Chapter was on 19 December 2008.

The statistical data on the infringements of intellectual property rights in the Republic of Croatia, as presented in this report, have been processed in accordance with the existing methodology developed following the requests having arisen from the negotiation process for the accession to the European Union.

Statistical data on offenders (perpetrators of criminal offences) and misdemeanants (perpetrators of misdemeanours) are based on the official data provided by the Ministry of Justice and the State Attorney Office of the Republic of Croatia. The data on offenders comprising infringements of intellectual property relate to the persons as reported, accused and convicted. The methodology includes final decisions issued by the State Attorney Offices on reports of criminal offences, as well as final court decisions. The data on the misdemeanants relate to natural persons accused and to those found guilty, as well as to legal persons found responsible for a misdemeanour comprising infringements of intellectual property. The methodology includes final decisions final decisions taken by Magistrates' courts.

Data provided by the Ministry of the Interior for the period up to 2010 relate to the number of filed criminal reports relating to crimes infringing intellectual property. Since 1 January 2011 the data are based on the number of criminal offences as committed and the number of persons reported for such criminal offenses.

Data provided by the Customs Administration relate to the number of procedures instituted *ex officio* and the number of procedures upon the right holder's request instituted. In addition to this, the presentations have been made of data on the goods

as destroyed, data on the stay of proceedings, and data on the cases pending before courts. The stay of proceedings relates to the cases in which the right holder, after detention of goods, failed to initiate further proceeding due to the fact that these goods were original (genuine) or the right holder had no interest in taking measures for the protection of one's own right notwithstanding that counterfeit goods were concerned. Data on the value of goods expressed in EUR, as well as the number and types of products are presented. Since 1.1.2009, the Customs Administration has not monitored the value of the goods as declared, but has monitored the amount of damage that would be suffered by the right holder if such goods were released into free circulation, representing a retail price of such original goods on the domestic market, expressed in EUR.

The data provided by the State Inspectorate relate to the number of inspections carried out by trade inspectors, and the number of requests for the institution of the misdemeanour trial with respect to any individual infringement of intellectual property rights as filed. Moreover, the data were presented on the type and number of provisional seizure of goods concerning the infringements of trademark provisions.

The data provided by the Ministry of Justice refer to the number of cases before the commercial courts (four commercial courts having jurisdiction) before the High Commercial Court of the Republic of Croatia, and the number of cases before the Administrative Court of the Republic of Croatia, as well as the mode of their settlement and duration of the procedure. The data have also been presented concerning duration of the procedure from filing of a criminal complaint until the pronouncement of enforceable judgement.

EXECUTIVE SUMMARY

THE CUSTOMS

In 2011 the Customs Administration initiated 645 procedures concerning the shipments of goods allegedly infringing intellectual property rights. Of these 645 procedures, 127 (19,7 %) were initiated *ex officio* and 518 (80,3 %) upon the right holder's request.

The goods were destroyed in 455 (70,5 %) and released in 170 (26,4 %) procedures, meanwhile 20 (3,1 %) procedures have been pending awaiting the court decisions about the goods concerned.

In 2011 the Customs initiated procedures for 1.564.663 products. According to the type, the majority of products were of the following three groups:

•	Other	995.151	(63,61 %)
•	Footwear	261.926	(16,73 %)
•	Clothes and clothing accessories	167.501	(10,70 %)

A total of 455.987 counterfeited products were destroyed of the aggregate retail value of EUR 50.4 million.

Statistical data comparison for 2010 and 2011

Comparing the years 2010 and 2011, the aggregate number of initiated procedures increased from 471 to 645 (31,2 %), thereby *ex officio* procedures decreased from 169 to 127 (24,8 %), and the number of procedures upon the right holder's request increased from 302 to 518 (71,5 %) procedures.

In 2011 the number of procedures under which the products were destroyed increased from 254 to 455 (79,1 %) and released decreased from 204 to 170 (16,7 %). The number of procedures referred to the court for decisions increased from 13 to 20 (53,8 %).

The retail value of the detained and destroyed products significantly increased (by 113 %) from EUR 23.7 to 50,4 million.

STATE INSPECTORATE

In 2011 the State Inspectorate carried out a total of 11.212 supervisions related to the protection of intellectual property rights, 1.048 (9,3 %) of these resulted in indictments for instituting misdemeanour trial.

Of the mentioned number of supervisions, 8.893 (79.3 %) referred to the supervisions on the protection of copyright and related rights, and 2.319 (20,7 %) to the supervisions on the protection of industrial property rights.

Of the mentioned number of indictments for instituting misdemeanour trial, 700 of these (66,8 %) referred to copyright infringements and 348 (33,2 %) to industrial property rights infringements.

The aggregate value of the products detained by the State Inspectorate in 2011 owing to the infringements of intellectual property rights accounted for EUR 233.562.

Copyright infringements of computer programs were found in 562 supervisions and at that occasion on 695 computers 1.342 computer programs were found installed without the author's consent (the value of the illegally installed computer programs has not been monitored since 2007).

In 2011 the State Inspectorate temporarily detained 41.280 products for infringement trademark. The main products were of the three following groups:

•	Clothes and clothing accessories	22.375	pcs. (54,21 %)
•	Footwear	12.189	pcs. (29,53 %)
•	Toys, games and sports equipment	4.921	pcs. (11,92 %).

Statistical data comparison for 2010 and 2011

Comparing the years 2010 and 2011 the aggregate number of supervisions increased from 10.779 to 11.212 (34,0 %) and the number of indictments for instituting misdemeanour trial increased from 957 to 1.048 (9,5 %).

The number of supervisions on the infringements of copyright and related rights increased from 8.100 to 8.893 (9,8 %), whereas the number of supervisions concerning the infringements of industrial property rights decreased from 2.679 to 2.319 (13,4 %).

The number of indictments for instituting misdemeanour trial concerning the infringements of copyright increased from 540 to 700 (29,6 %) and the number of indictments for instituting misdemeanour trial concerning the infringements of industrial property rights decreased from 417 to 348 (16,5 %).

The aggregate number of detained products increased from 12.742 to 41.280 pieces (67,0 %), while the aggregate value in EUR of detained products increased from 110.431,15 to 233.561,53 \in (111,5 %).

MINISTRY OF THE INTERIOR

In 2011, the Ministry of the Interior reported 181 adult persons for committing 413 criminal offenses in respect of infringement of intellectual property rights. Of these 108 persons were reported for 273 criminal offenses of copyright infringement, and 73 persons for 140 criminal offenses of infringement of intellectual property rights.

Statistical data comparison for 2010 and 2011

Comparison can not be carried out because the data on the number of criminal offences as committed and the number of persons reported for such criminal offenses have been monitored since 1 January 2011.

STATE ATTORNEY OFFICE

In 2011 the State Attorney Office was reported 337 infringers concerning the infringements of intellectual property rights. 236 (70,0 %) of these were infringers of copyright, and 101 (30,0 %) infringers of industrial property rights.

The State Attorney Office passed in whole 206 decisions against infringers for infringing intellectual property rights. Of these 110 (55,5 %) resulted in indictments for the infringements of copyright, 34 (17,2 %) decisions resulted in indictments for the

infringements of industrial property rights, whereas 38 (19.2 %) decisions resulted in rejecting criminal complaints against copyright infringers. With respect to the infringements of industrial property rights 16 (8,1 %) decisions on rejecting criminal complaints were made.

Statistical data comparison for 2010 and 2011

Comparing the years 2010 and 2011 the number of reported infringers of intellectual property rights increased from 153 to 337 (120,3%). The number of reported infringers of copyright infringements increased from 140 to 236 (68,6%) and the number of reported infringers about infringing industrial property rights increased from 13 to 101 (677%).

The number of decisions taken against infringers resulting in indictments for copyright infringements increased from 45 to 110 (144 %), and for infringing industrial property rights it increased from 6 to 34 (467 %).

The number of decisions issued against the perpetrators of criminal offences that resulted in the rejection of reports has increased from 10 to 38 (280%) for the perpetrators of copyright infringement and 0 to 16 for the perpetrators of industrial property rights infringement.

<u>JUDICIARY</u>

Criminal Courts

In 2011 of the persons accused 135 were accused for infringing intellectual property rights, of these 99 (73,3 %) were charged for copyright infringements, and 36 (26,7 %) for infringing industrial property rights.

Of 135 persons accused for infringing intellectual property rights, 105 persons (77,8 %) were found guilty. Of these persons 71 (67,6 %) were found guilty for copyright infringements, and 34 persons (32,4 %) for infringing industrial property rights.

Of 105 persons found guilty, three of them (2,8 %) were imposed an unconditional prison sentence, 65 persons (62,0 %) were imposed a suspended sentence, whereas the rest was imposed a fine.

Statistical data comparison for 2010 and 2011

Comparing the years 2010 and 2011 the number of persons accused for infringing intellectual property rights decreased from 239 to 135 (39,3 %).

The number of persons found guilty for infringing intellectual property rights decreased from 203 to 105 (48,3 %). The proportion of persons sentenced to unconditional or conditional imprisonment increased from 54,6% to 64.8%.

Magistrates' Courts

In 2011 misdemeanour trials were instituted against 4.791 natural persons for the infringements of copyright provisions. Consequently 2.686 persons (56,1 %) were found guilty, of these five persons was sentenced to imprisonment, and 2.642 persons (98,4 %) were imposed a fine. The other persons were admonished.

Under misdemeanour trials conducted against legal and responsible persons, misdemeanour trials were instituted against 2.404 persons for the infringements of copyright provisions. Thereby 1427 persons (59,3 %) were found responsible, of these 1.376 of (96.4 %) were imposed a fine. The other persons were admonished.

Misdemeanour trials were instituted against 236 natural persons for the infringements of trademark provisions. Thereby 158 persons (66,9 %) were found guilty, of these 156 (98,7 %) were imposed a fine. The other persons were admonished.

Misdemeanour trials were instituted against 71 legal entities and responsible persons for the infringements of trademark provisions. Thereby 57 (80,3 %) persons were found responsible, of these persons 55 were imposed a fine. The other persons were admonished.

Statistical data comparison for 2010 and 2011

Comparing the years 2010 and 2011, the number of natural persons against whom misdemeanour trials were instituted for the infringements of copyright provisions increased from 3.083 to 4.791 (55.5 %), and the number of legal entities increased from 2.126 to 2.404 (11,1 %).

The number of natural persons against whom misdemeanour trials were instituted for the infringements of trademark provisions decreased from 438 to 236 (23,3%), whereas the number of legal entities increased from 49 to 71 (44,9%).

The number of court cases and duration of procedures

Administrative Court of the Republic of Croatia

On 1 January 2011 the Administrative Court of the Republic of Croatia had 141 pending cases in the field of industrial property rights. In the course of that year 12 new cases were received and 131 (86,6%) cases decided. Consequently, on 31 December 2011, unsolved remained 22 cases in the field of industrial property rights.

In 2011 the Administrative Court of the Republic of Croatia decided on 131 cases, 110 (84,0 %) of these were decided within two to three years, 15 (11,5 %) cases were decided within one to two years, and other six (4,6 %) within one year period.

Commercial Courts

On 1 January 2011 the competent commercial courts had pending 1.374 cases in the field of intellectual property rights. In the course of that year 1.588 new cases were received, and 1.503 cases decided. Consequently, on 31 December 2011 1.459 were pending cases in the field of intellectual property rights.

In 2011 of 1.503 decided cases, 953 (63,4 %) were decided within a one year period, and 481 (32,0 %) within a two year period.

High Commercial Court of the Republic of Croatia

On 1 January 2011 the High Commercial Court of the Republic of Croatia had 380 pending cases in the field of intellectual property rights. In the course of 2011 were

received 197 new cases and 259 (44,9 %) decided. Consequently, on 31 December 2011 there were 318 pending cases in the field of intellectual property rights.

In 2011 of 259 decided cases, 134 cases (52,3 %) were decided within a six-month period, and 106 cases (40,9 %) within a twelve-month period.

Criminal Courts

In 2011 criminal courts decided in whole 135 cases for infringing intellectual property rights. 99 (73,3 %) of these referred to the copyright infringements, and 36 (26,7 %) to the infringements of industrial property rights.

In the course of a one year period, in whole were decided 90 (69,2 %) cases in the field of intellectual property rights, of these 65 referred to copyright infringements, and 25 cases to infringements of industrial property rights.

In the course of one to two years in whole were decided 29 (22,3 %) cases in the field of intellectual property rights, 23 of these referred to copyright infringements, and 6 cases to infringements of industrial property rights.

Magistrate's Courts

In 2011 Magistrate's courts decided in whole 3.254 cases for infringing the provisions of intellectual property rights. Of these 3.063 (94,1 %) referred to the infringements of copyright provisions, 190 (5,8 %) cases referred to the infringements of trademark provisions and one case to the infringements of patent provisions.

Of the aggregate number of cases decided in 2011 by Magistrate's courts referring to the infringements of the provisions on intellectual property rights, 2.679 (82,3 %) were decided in one year period, 2.447 of these cases referred to the infringements of the copyright provisions and 132 cases referred to the infringements of the trademark provisions.

In the course of one to two years, in whole 354 (10,9%) cases were decided, of these 332 referred to the infringements of the copyright provisions and 22 cases referred to the infringements of the trademark provisions.

In the course of two to three years, in whole 114 (3,5 %) cases were decided.

2. CRIMINAL LAW AND MISDEMEANOUR LAW PROTECTION – COMPREHENSIVE COURSE OF ACTION UNDER CRIMINAL AND MISDEMEANOUR PROCEDURES

2.1. Comprehensive course of action of a criminal procedure from filing a criminal complaint until the criminal court decision in 2011

In 2011, the Ministry of the Interior (Police) has filed 413 criminal reports for infringements of intellectual property rights, the State Attorney's Offices issued decisions against 206 perpetrators of criminal offences for the infringements of intellectual property rights, while criminal courts issued decisions against 135 accused persons and pronounced 90 sentences (3 sentences are unconditional imprisonment).

2.2. Comprehensive course of action of a misdemeanour trial in 2011

In 2011 in whole 5.028 misdemeanour reports were filed against natural persons for infringing the provisions of intellectual property. 2.845 natural persons were found guilty and imposed the identical number of sanctions. The majority of fine sentences were imposed, namely 2.789 (98.0 %).

In the same period 2.478 reports were filed against legal and responsible persons for infringing the provisions of intellectual property. 1.487 legal entities were found responsible and imposed a fine sentence, namely 1.438.

For the purpose of presenting statistical data within the competence of the Customs Administration of the Republic of Croatia, the statistical tables have been compiled on:

- the number of procedures and the number of provisionally detained goods, according to the product specifications (foodstuffs and beverages, medicines, garments and accessories, sports and other footwear, electric, electronic and computer equipment, body care products, toys, tobacco products and other)
- the number of procedures according to the products specifications of provisionally detained goods and according to the outcome of procedures (destruction of goods as provisionally detained, taking of legal action before a competent court or stay of proceedings)
- the number of provisionally detained goods according to the products specifications and according to the outcome of procedures,
- the value of goods as provisionally detained according to the products specifications, expressed in EUR.

– Customs Administration



Outcomes of the procedures instituted in the cases of infringements of intellectual property rights – Customs Administration



Chart 3.3. Portions of the types of products in the aggregate number of dubious products in the course of 2011 - Customs Administration



The cases of infringements of intellectual property rights, mostly encountered by trade inspectors of the State Inspectorate when carrying out their inspections, was placing into circulation of the products infringing the copyright (pirated copies) and trademark rights (counterfeits).

In relation to data on the inspections carried out (since 1 January 2010 the aggregate number of inspections has been monitored) on the protection of copyright, the presentations include statistical data on:

- inspections relating to the protection of copyright in computer programs (the number of computers inspected, the number of illegally installed computer programs and their value expressed in EUR, as well as the number of presented indictments and misdemeanour reports),
- inspections relating to the circulation of musical and cinematographic works recorded on audio and video carriers without the author's consent – pirated copies (the number of provisionally detained goods and their value expressed in EUR, and the number of presented indictments and misdemeanour reports),
- inspections relating to the circulation and reproduction of books made without the author's and publisher's consent (the number of provisionally detained goods and their value expressed in EUR, and the number of presented indictments and misdemeanour reports).

In relation to data on the inspections carried out over the protection of industrial property, the statistical data are presented on:

 inspections related to the circulation of branded products without an authorisation of the trademark owner - counterfeits (the number of inspections, the number of provisionally detained goods and their value in EURs, and the number of presented indictments and misdemeanour reports),

- specifications and quantities of goods as provisionally detained in compliance with the Trademark Act (garments, footwear, leather accessories, watches, eyeglasses, perfumes and other),

Chart 4.1. Data on the infringements of intellectual property rights in 2011 – State Inspectorate



The value of provisionally detained audio and video carriers, expressed in EUR - State Inspectorate



The value of provisionally detained goods for infringing the trademark provisions, as expressed in EUR – State Inspectorate



Chart 4.4. Proportion of the particular types of provisionally detained goods under the Trademark Act in 2011 – State Inspectorate









Chart 6.2. Trends for adult persons reported on criminal offences relating to copyright (data from Tables 6.2. and 6.3.) – State Attorney Office



Trends of criminal complaints rejections concerning the infringements of copyright (aggregate data of Tables 6.2. and 6.3.) – State Attorney Office








Trends of adult persons reported for criminal offences - Infringements of the rights conferred by an invention applied for or protected - State Attorney Office



Trends of adult persons reported for criminal offences - Infringement of industrial property rights and an unauthorized use of another person's property - State Attorney Office




Chart 6.8. Trends in rejecting criminal complaints for the infringements of industrial property rights - State Attorney Office




Chart 6.9. Trends of indictments filed against the infringements of industrial property rights - State Attorney Office




7. CRIMINAL COURTS - DECISIONS

7.1. Criminal Law Sanctions

As regards the course of action of criminal procedure following the issue of an indictment or a charge brought by the State Attorney Office, concerning the infringements of intellectual property rights, a presentation in detail is given of statistical data on the aggregate number of persons accused, the number of persons found guilty and of the types of decisions taken by criminal courts in cases persons were not found guilty, such as:

- the number of discontinuation of the criminal proceedings
- the number of dismissal of claims
- the number of acquittals
- the number of persons not found guilty being mentally incompetent.

The structure of criminal sanctions imposed in these criminal offences has been presented, for each single type of criminal offence referring to the infringement of intellectual property rights.

The statistical data have also been presented concerning the number of judicial proceedings in which offenders were imposed security measures of detention of goods and material gain, as well as data concerning cost estimates of the fines imposed.

Chart 7.1.1. Legal forms of decisions concerning all infringements of intellectual property rights, 2011 - Criminal courts



Trends of adult persons accused and found guilty for a criminal offence – infringement of the rights of authors or the rights of performers, Art. 229 CC – Court decisions









Chart 7.1.7. Unconditional imprisonments for a criminal offence Infringements of copyright – pirated copies



Conditional imprisonments for criminal offences Infringements of copyright – pirated copies



Chart 7.1.9. Unconditional fines (expressed in daily income) for criminal offences: Infringements of copyright – pirated copies




Chart 7.1.10. Conditional fines (expressed in daily income) for criminal offences Infringements of copyright – pirated copies



Chart 7.1.11. Unconditional fines (expressed in daily income) for criminal offences Infringements of intellectual property rights







The number of judicial procedures in which imposed a security measure of seizure of goods and a special measure of material gain seizure for the Infringements of copyright provisions



The number of judicial proceedings imposing a security measure of seizing goods and a special measure of seizing material gain for the infringements of industrial property rights






Chart 7.1.16. Account of fines imposed on offenders for copyright infringement – pirated copies

Chart 7.1.17. Account of fines imposed on offenders for infringements of industrial property rights






Natural persons accused and found guilty for infringing the copyright law provisions from 2002 to 2011



Legal persons accused and found responsible for infringing the copyright law provisions from 2002 to 2011



Natural persons accused and found guilty for the infringements of the provisions on trademark and other symbols from 2002 to 2011



Legal persons accused and found responsible for infringements of the provisions on trademark and other symbols from 2002 to 2011









Chart 9.1.2. Duration of the procedure from filing a criminal complaint to the final court decision in 2011 - industrial property rights

Chart 9.2.1. Duration of the procedure from filing a misdemeanour report to the final court decision in 2011 – Infringements of the provisions on copyright





Chart 9.2.2. Duration of the procedure from filing a misdemeanour report to the final court decision in 2011 - Infringements of the provisions on trademark and other symbols






Chart 9.3.1. Duration of the procedure before commercial courts in 2011
