### 1. FILING A PATENT APPLICATION

**Note:**

1. If the patent application is submitted electronically in accordance with special regulations or in digital form in accordance with the technical specifications published on the website of the Office, the costs shall be reduced by 50%.
2. Where the publication of the patent application is required before the expiration of 18 months from the date of its filing, the formal examination costs shall double.
3. After the application has been filed and priority granted, the applicant may optionally request to be issued the Priority Certificate, subject to the coverage of costs of 150 HRK / 19,91 EUR for one copy of the Certificate, and 50 HRK / 6,64 EUR for each additional copy thereof.

### 2. PREPARATION OF A STATE OF THE ART SEARCH REPORT

In order for the patent grant procedure to continue, the applicant must file a request and pay the cost for a state of the art search report. The applicant may request that either the State Intellectual Property Office or the European Patent Office prepare a search report.
