NOTE:

Minimal total procedural costs for the registration and maintenance of a trademark for the period of ten years, for individual trademark without reduction, shall include costs under 1.a)1. and 2.a)1., or the total amount of 1700 HRK / 225,63 EUR¹. For collective or guarantee trademark, the respective minimal costs are specified under 1.b)1. and 2.b)1., or the total amount of 3400 HRK / 451,26 EUR¹.

IMPORTANT NOTE:

This list specifies only basic procedural costs for the registration and maintenance of a trademark. Depending on the settlement of regular obligations by the applicant and on additional requests pending procedure, the applicant may incur additional costs not specified in this list. Certain categories of applicants are eligible for fee reduction.
