Listed costs are annual and their regular payment is a condition for maintaining the utility model in value. **The annual payment of maintenance costs is paid for the first time for the third year of maintenance, counting from the day of filing the application - of one's own accord, without an invitation from the Office.**

If the costs are paid with delay (within an additional six-month period) the prescribed amounts are doubled.

This list specifies only basic costs of the procedure for the registration and maintenance of a utility model. Depending on the applicant's regular obligations settlement during the procedure and on other requests of the applicant, additional costs may incur that are not specified in this list. Certain categories of applicants are eligible for reduction of costs.
